

ScotchBlue™ Painter's Tape Sweepstakes OFFICIAL RULES

NO PURCHASE OR PAYMENT IS NECESSARY TO ENTER, PARTICIPATE, OR WIN. A purchase does not improve your chances of winning. By entering the Sweepstakes, entrant fully and unconditionally agrees to and accepts these Official Rules. Open only to legal residents of the fifty United States and the District of Columbia who are 18 years of age or older and the age of majority in applicable jurisdiction as of the date of entry and have a valid driver's license. Void where prohibited or restricted by law. All federal, state, and local laws and regulations apply.

1. **PROMOTION PERIOD:** ScotchBlue™ Painter's Tape Sweepstakes (the "Sweepstakes") begins at 12:01 a.m. Eastern Time ("ET") on July 1, 2018 and ends at 11:59 p.m. ET on August 31, 2018 (the "Promotion Period"). Sponsor is the official time keeping device for the Sweepstakes.
2. **SPONSOR:** 3M Company, 3M Center, Building 0223-04S, St. Paul, MN 55144 (the "Sponsor").
3. **ELIGIBILITY:** The Sweepstakes is open only to legal residents of the fifty (50) United States and the District of Columbia who are 18 years of age or older and the age of majority in applicable jurisdiction as of the date of entry and have a valid driver's license.
